# Remote Online Notary (RON) for FOREIGN CITIZENS

This RON company has assisted many Foreign Citizens residing or traveling outside the USA with Remote Online Notarizations. Signing instructions available in multiple languages. An Interpreter can be added to Zoom, WhatsApp or Face Time video meeting.

#### Florida Remote Notary can assist a Foreign Citizen. (No Social Security or EIN Number Required.)

Florida Statutes 117.201 (6) "Government-issued identification credential" means any approved credential for verifying identity under s. 117.05(5)(b)2. However, for an online notarization of a principal not located within the United States, a passport issued by a foreign government not including the stamp of the United States Bureau of Citizenship and Immigration Services may be used as a government-issued identification credential to verify the principal's identity.

### Biometrics Required for International Passports using Florida RON.

**BIOMETRICS** 117.201. (7) "Identity proofing" means a process or service in compliance with applicable law in which a third party affirms the identity of an individual through use of public or proprietary data sources, which may include by means of knowledge-based authentication or **biometric verification**.

#### **Identification Affidavit of International Citizen**

**Some Title Underwriters** require an Identity Affidavit signed during the Remote Notary session by an individual who attests under penalty of perjury, **personal knowledge** of the Foreign Citizen signer(s). This person must be a USA citizen and pass knowledge-based identity verification. The form requires specific details of in-person meetings and other communications.

#### Signers Can Be Anywhere in the World

Florida Statutes 117.265 (1) An online notary public physically located in this state may perform an online notarization that meets the requirements of this part regardless of whether the principal or any witnesses are physically located in this state (Florida) at the time of the online notarization. We have assisted signers located in over 30 countries and the list is growing.

### Witnesses Must Be In The USA

**Florida Statutes 117.285 (4)** A witness remote from the principal and appearing through audio-video communication technology must verbally confirm that he or she is a resident of and physically located within the United States or a territory of the United States at the time of witnessing. Only our verified, disinterested witnesses are allowed on our Zoom video calls.

It is always recommended you contact the third party or Title Underwriter on acceptance of digitally signed documents using Remote Notarization.
